By completing this form, I certify to TREC and all associated parties that I have read, understand and accept the following representation, stipulations and waiver. I further understand that TREC and any associated parties or individuals will not accept legal liability for any injury, incident, occurrence or damage arising from participation in any TREC series or activity and that my participation in such activities must be at **my own risk**.

With signatures on this form, the undersigned hereby releases TREC and all their respective representatives, agents, sponsors, and volunteers ('releasees') of all liability to the undersigned, whether caused by negligent acts of omission of releasees or otherwise while the undersigned is for any purpose participating in such series. It is fully understood by each of the undersigned that there is some inherent risk associated with the series, including damage to vehicles and personal property and personal harm to the individual.

IN ADDITION, the undersigned **AGREES TO INDEMNIFY AND HOLD HARMLESS** the releasees from any loss, liability, damage or cost they incur due to such participation by the undersigned, whether caused by releasees' negligence or otherwise, and **AGREES TO ASSUME FULL RESPONSIBILITY AND RISK** from bodily injury, death or property damage from releasees' negligence or otherwise while the undersigned is participating in the series.

**In signing this Waiver and Release, the undersigned hereby acknowledges and represents the following:**

1. Racers and navigators will at all times while participating in the series, wear his or her respective seat and/or shoulder belts and have been informed and advised that wearing a D.O.T. approved helmet is to be worn at all times while riding in a vehicle and while otherwise participating in the series.
2. That the vehicle meets safety requirements and is fit for the application.
3. That the owner/racer certifies that he/she has inspected their vehicle and certifies it to be in good mechanical condition & road worthy to participate in the series and that it is insured to cover all property and medical risk associated with the series.
4. That the owner/racer/navigator has informed himself/herself about the series, either by prior participation or by investigation into the series and is aware of all risks associated therewith.
5. That the racer or any other person(s) in a vehicle or otherwise participating in the series may choose to cease racing at any time and therefore, assumes all risks and liability, as indicated above.
6. That any video footage or photography taken during the series is the property of TREC, and may be used at their discretion. I have read and understand the above liability release form.
